



## **Information on California Proposition 65**

Dear valued customer,

As you may know, American RENOLIT Corporation (“ARC”) manufactures and sells plastics vinyl film (“Film”) that may contain chemicals listed under California Proposition 65 as causing cancer and reproductive toxicity.

To ensure compliance with Proposition 65, ARC hereby provides its customers the following warning and/or the information if any of the sold products contain any substances that are listed under Proposition 65 and where individuals in the State of California may be exposed to these substances in the workplace or as a consumer.

California Proposition 65, the Safe Drinking Water and Toxic Enforcement Act of 1986, is intended to protect California citizens and the State's drinking water sources from chemicals known to cause cancer, birth defects or other reproductive harm, and to inform citizens about exposures to such chemicals.

It applies at all levels of products throughout the supply chain that are shipped to or manufactured to the State of California. Again, suppliers and distributors must inform consumers that they are exposed to chemicals known to cause cancer and/or reproductive harm.

The Manufacturer of the consumer product must pass the warning on so that the end product is labelled. Consumers can then decide, if they want to purchase or use product.

Proposition 65 warning does not mean a product is in violation of any product-safety standards or requirements. It does not mean that the product is generally unsafe; however, employees and consumers should be made aware of possible health concerns. A Proposition 65 warning does not mean that the product will actually cause cancer or other reproductive harm when used in its intended manner.

## Safe harbor levels

The Office of Environmental Health Hazard Assessment (“OEHHA”) adopts safe harbor levels for many of the listed chemicals <http://oehha.ca.gov/prop65/pdf/safeharbor081513.pdf> . If the product causes an exposure greater than the safe harbor level, then rules relating to Proposition 65 must be followed.

## Product Labeling

The law requires companies to provide a "clear and reasonable" warning before exposing persons in the State of California to chemicals that are considered harmful. The law does not ban the use of these chemicals, but is intended to ensure that people are informed about their potential exposure.

The word “WARNING” is in all capital letters, print to be bold and it must be conspicuous.

ARC has therefore added this warning to rolls of film shipped to customer located in the State of California for products containing listed substances

## **Sales documents**

ARC has introduced the warning on sales documents for all products shipped directly into the State of California.

## **Penalties**

If not in compliance, businesses may have to pay significant penalties in the amount of \$2,500 per day for each violation.

## **Companies located outside the State of California:**

This law imposes requirements on any products and processes that enter the State of California regardless of its origination.

As a non-resident company we advise you to seek professional and/or legal counsel to understand your obligations under the law.

## **ARC and PROPOSITION 65:**

As an Indiana business ARC complies with the requirements of Proposition 65, informing direct customers in the State of California if listed chemicals are used within the product.

ARC offers product regulatory compliance information based on customer request to ensure that this information will be channeled through to the whole supply chain up to the final warning on the consumer product.

In the near future ARC may extend the product warning label for all shipments to customers outside the State of California and may also include the warning on related sales documents.
